5. No relaxation in the prescribed fee in any case shall be entertained.
6. The candidates appearing in this examination are essentially required to attach copies of their Registration Slips and previous Marks Sheets of 1st, 2nd year Examination, else the Board shall be constrained to withhold their admit cards. The consolidated result of such candidates will not be finalized.
